# POSITION DESCRIPTION

#### **Primary Purpose**

In response to God's calling and in the power of the Holy Spirit, the PowerBI Reporting Analyst works to gather, analyse and communicate information that supports effective decision making by managers and employees, as well as developing the reporting platforms required to provide the ministry with meaningful, insightful, engaging and transparent information.

#### **Key Accountabilities**

- Assist in the development of the ministry intelligence platform through increased functionality
  of new dimensions, measures and the visualisation of data to support automated reporting
- Development of automated standard dashboards and reports, including high level summaries on results across all ministry programs, campaigns and appeals using PowerBI platform
- Evaluate effectiveness of existing data and reporting systems, and develop new reporting systems to improve workflow, quality and/or timeliness where appropriate
- Contribute to the Data & Analytics team culture, ensuring fit for purpose reporting solutions are scoped, recommended and developed in line with stakeholder expectations.
- Directing analysis and discussions to elicit targeted business requirements that are fit for purpose
- Work independently, with multiple cross-functional project teams and business units to prepare comprehensive business requirements documents that meet the needs of stakeholders
- Provide operational, technical data and reporting advice to support stakeholders and sections across the ministry as required
- Other relevant duties as required
