POSITION DESCRIPTION

Primary Purpose

In response to God's calling and in the power of the Holy Spirit, Ithe Quality Assurance Analyst is responsible for working with stakeholders (technical and non-technical) to plan, design and execute test cases to ensure high quality outcomes are delivered from Compassion Australia's technology projects. In addition, this role is responsible for working with non-technical stakeholders to support/coach them through test execution. The QA Analysts is also expected to proactively contribute to improving testing standards, documentation, strategies and management of requirements and defects.

Key Accountabilities

- Create end-to-end test plans by collaborating with subject matter experts, business analysts and developers
 - o Functional/Non-functional testing
 - o Integration testing
 - o Regression testing
 - o User-Acceptance
- Develop test plans that include:
 - Testing coverage and fit-for-purpose testing measures/indicators (analyse, interpret, and present results/metrics to stakeholders)
 - Track and manage issues uncovered during testing
 - Provide input into the process for resolving defects/rework that is required
 - Outstanding documentation practices
- Configure and manage test environments and related testing data (including deidentification, privacy and policy compliance)
- Recommend and develop standardised and / or automated testing where suitable
- Contribute to project schedule (collaboration with PMs)
- Support/coach end-users and champion in the testing process
- Adhere to Quality Assurance frameworks/standards; and contribute to their enhancement
- Any other duties as required
